Your Input Is Needed On Interstate 10 Corridor Study, Junction Interstate 8 to Tangerine Road Design Concept Report and Environmental Assessment

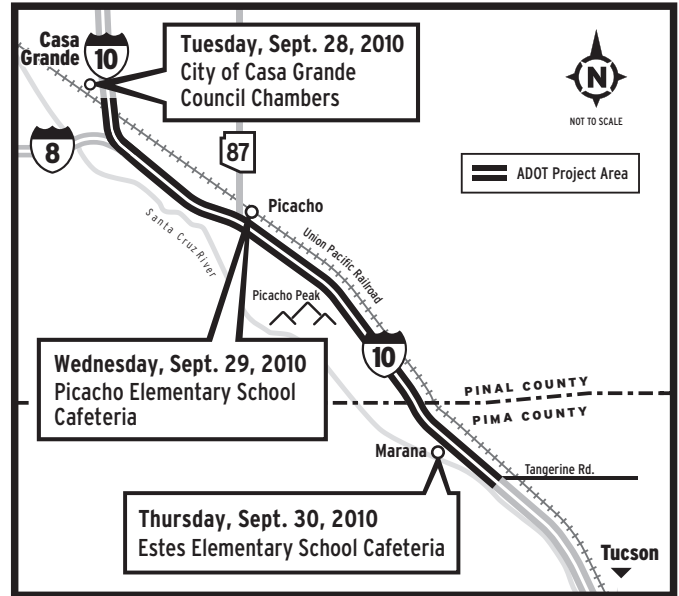

ADOT representatives and the study team will be available to address concerns and answer questions. ADOT will receive public comment by written comment form, by spoken comment at the formal comment session or by spoken comment given to the court reporter who will be present at the meeting.

The purpose of the study is to develop a long-range plan to accommodate future traffic projections and establish a framework for future improvement projects as traffic volume increases.
